

How does it work?

Your medical records are shared among family doctors, hospitals, long-term care homes and community care access centres across Ontario.

- Your personal health information is made available to participating health care organizations for the purpose of providing care and treatment.
- All health care organizations handle personal health information in accordance with Ontario's health privacy law (Personal Health Information Protection Act, 2004).
- Only authorized members of your health care team can view your electronic health information.

We take your privacy seriously

Your privacy rights
